Safety Round Up update

As an electric cooperative and a Touchstone Energy member, we adhere to seven cooperative principles and four core values. At the heart of this is a concern and commitment to our communities. As we have touted in this publication many times, safety is our highest priority, and this commitment extends beyond the safety of our employees to the communities we serve.

As part of our Commitment to Community, Vigilante Electric offers Safety Round Up. This program aims to accumulate and disburse funds to organizations that help keep our communities safe. Recipients of Safety Roundup funds do not have to be cooperative members but must be part of the communities within our service territory.

The funds to support this program are collected from members who voluntarily allow us to round up their electric bills to the next whole dollar. The average cost per meter will be \$6 a year. The maximum a person could pay per meter is \$11.88. Individually, it is not much, but collectively, this program can do great good.

Since launching this program in 2017, Vigilante Electric Safety Round Up has issued 17 grants for safety-related projects. The last two grants were

to the Broadwater County Search and Rescue and the Beaverhead Co. DUI Task Force.

At our July trustees meeting, the board awarded \$1,000 to Broadwater Co. S&R. This grant will be combined with other funds to purchase a new truck to tow their lake rescue boat. At the August meeting the board approved a \$3,000 grant to Beaverhead Co. DUI Task Force for free sober rides during Labor Day weekend in Dillon.

Safety Roundup embodies the cooperative spirit and is a shining example

of us living out one of our core principles. Vigilante Electric is proud to be associated with this program and we would like to thank all our participating members. Without you, this program does not exist.

HELP FOR THOSE IN NEED

LIHEAP and other programs are there for low-income households that may need energy help this winter

THE Old Farmer's Almanac predicts cold weather with an average snowfall this coming winter. Whether or not you buy into this, for me, it conjures up memories of some of the harsher elements we faced these past two winters, and the reality of the pressure cold weather places on our utility bills. This is on top of the fact that the cost of most, if not all, consumer products continues to rise. For low-income families, winter utilities can become an overwhelming financial burden.

All cooperatives function under the ideals of honesty, openness, social responsibility and caring for others. Since 1998, Vigilante Electric Cooperative has helped qualified members with winter heating needs. Applications for our assistance program are available starting October 1, and must be returned by November 27, 2024. You can contact us at (800) 221-8271 or (406) 683-2327 for an application.

The funding level for Vigilante's program is limited. We strongly recommend that families in need also apply for the programs offered by the Department of Public Health and Human Services (DPHHS).

DPHHS administers federally funded programs designed to help low-income families. Here is a brief description of the opportunities available and income guidelines (the same we use) for the upcoming heating season.

LIHEAP

The Low-Income Home Energy Assistance Program (LIHEAP) pays part of winter energy bills and may be able to assist with furnace emergencies for eligible people.

Weatherization

The Weatherization Program helps participants improve the heating efficiency of their homes and thus reduce their energy consumption.

Energy Share of Montana

Energy Share of Montana is a private nonprofit organization whose primary purpose is to help Montanans facing energy emergencies meet their needs and move toward self-reliance.

If you qualify, call for an application, and be sure to inquire about the weatherization program. Where LIHEAP helps with your immediate needs, weatherization is a longterm solution that helps lower your energy bills. You may automatically qualify if you receive benefits from programs such as SNAP, SSI or TANF.

These programs are administered through regional offices. Each office serves specific counties, so contact the office nearest you.

Safety first with backup generators

Montana. While our service territory was mostly spared, neighboring cooperatives were not as lucky. If you watched the news, these storms left hundreds of cooperative members without power for extended periods. A way to minimize the impact of a long-term outage is to install a backup generator. Vigilante Electric Cooperative has no problem with members using backup generators, but the installation must be done correctly, or they can create some dangerous situations.

Under regular operation (a service connected to the distribution line), electricity is stepped down or transformed to more useful voltages. When an outage occurs, a generator can meet some or all home energy requirements. However, if the installation is not done correctly, the generator can back-feed onto the electrical distribution system, which is extremely dangerous for the line crews trying to restore power.

The National Electrical Code requires either a manual or automatic transfer switch. A transfer switch is a secondary circuit breaker panel that isolates a backup generator from the power grid. A properly installed transfer switch prevents feedback onto our distribution lines, protecting our linemen and the generator while the utility service is restored.

Another safety issue involves where the generator is located. According to the Consumer Products Safety Commission (an independent federal regulatory agency), in



2020, 92 people died from carbon monoxide poisoning while using portable generators.

Installing a generator and transfer switch is not overly complex; however, some projects are best left to professionals. A licensed electrician with expertise and knowledge of the National Electrical Code is best suited to select the size and install a generator to meet your needs, ensuring a safe and compliant installation.

If you have a backup generator and have not previously notified us, or intend to install one, please contact us so we can note the location. This knowledge is valuable to our line crews when trying to restore power.
